- Exchange students must take at least 51% of their credits in the Faculty of Geography and History. Foreign students may make credits in other faculties of the University of Barcelona prior authorization of the faculty in question.
- In the case of Master students, they may make a maximum of 25 ECTS credits, per academic year
- The research work will not be valid for the syllabus. Students will be able to take only subjects.
